## **Chamber of Commerce update for May 2018**

The chamber held a great golf tournament at Legacy Ridge County club during the month of May. With 17 teams participating and some great prizes everyone had a good time.

With school out and the summer months coming up the chamber activities slow down during this time of the year. We have some new members who will have ribbon cuttings in the next two months so please plan to attend those if possible.

The Autumn in Bonham bike rally on 9/29/2018 already has four riders registered. We will be coordinating the rest stops, snacks, etc. over the next month for this event. Our goal is to have 500 riders attend this year.

The Leadership Class started in May had a total of 22 people attend. The program is eight months long and the chamber is excited about offering a different class next year for those who were not able to attend this time.

## **Fannin County Multipurpose Complex Update for May 2018**

The weather is affecting the complex's electric bills earlier than usual due to the higher than normal temperatures during May. Normally we would only need 3-4 of the 7 ac units at the complex to keep events cool in May. We had to use all 7 for at least two events during the month which will add an additional \$400 to the Complex buildings electric bill for May.

For May, the complex hosted eight different events during the month. The Texas department of Criminal Justice used the facility twice for Officer Appreciation Day for their employees and other law enforcement within Fannin County. We also hosted the Ag Awareness day for the local schools. Bonham ISD used the facility twice due to construction at the high school: 1) Spring Sports Banquet and 2) The annual BISD awards and appreciation banquet for the school employees. The complex also had three weekend events that were billed at the full price for the rentals.

The BISD utilized the stage for their graduation ceremony on May 25, 2018. We move the stage to the football field the day before the event and then disassemble it and reset it in the complex as soon as graduation is over that night. Under our initial agreement with the school for helping to purchase the stage, we have two more years remaining under this arrangement.
