### **Chamber of Commerce update for April 2018**

The chamber has received the renewals for almost every member from last year and have had one Bronze member convert to a Gold Member this year (Fannin Bank). We have also had The First National Bank of Trenton join as a new gold member. Thanks to all our past members for renewing their investment in the Chamber and we look forward to making it a profitable investment on their part.

The newsletter this month is extremely well done and we would encourage you to go online and see just how much this resource has improved over the years. The chamber is continually striving to make improvements in our marketing products and ways we reach businesses and individuals. Our social media presence has improved over the years also (Thanks entirely to Susan) and we are always looking for ways to build on what we do to reach others.

The chamber is currently working on a project with the City of Bonham that if successful would move our outreach to an entirely different level of success over the next few months. We will let you know more as we finalize the details.

The Cattle Brand Wall on North Center street is almost ready to go. We have to get "WELCOME TO BONHAM" painted across the top of the building and we will be ready to start marketing this unique project for the community. A project of this type will draw in plenty of visitors to Bonham from the surrounding areas and we will work to market it like The Quilt Barn trial was.

#### Fannin County Multipurpose Complex Update for April 2018

The complex had a full April with events every weekend in addition to the Fannin County Future's fair and the 25<sup>th</sup> Anniversary for the Children's Center hosted at the complex.

We completed the drainage project in the RV park at a cost of \$2,200. This should eliminate standing water during and afternoon rains to a bare minimum. A small amount of work is still to be done on touching up the approaches to the RV pads but the rock for these projects is at the complex already. There is one more utility pad to pour as soon as the water faucet is installed.

With the city opening the fire hydrant every week now and running 30,000 gallons of water out each time, we have installed a 8 inch culvert across the road behind the pavilions to prevent the water from running down the side of the road as much. This redirects the water much farther up the road to the south and prevents standing water that interferes with the road and traffic.

A comment made by one of the RV park residents validated the effort to put in the sound panels in the main building. They asked if we had told the weekend bands to play quieter as they were not near as loud since the first of the year.
