Multipurpose Complex Update By Dale McQueen

The complex has a full schedule for the month of April 2016. Chi Lambda is holding their annual event on April 2nd. A private party is scheduled for April 9th, the men's Forge conference is on April 10th, Flyball will be back on April 16th and 17th. Pinkalicious will be at the complex on April 23rd and 24th. The Fannin County Relay for life will be held on April 30th at the complex.

A new stage has been delivered and set-up for its debut at the Chi Lambda event on April 2nd. This is a 24 foot by 20 foot stage with guardrails and steps that adjusts from 24 inches to 48 inches tall. The stage is completely aluminum so it can be set-up in any weather conditions with no chance for damage if left out in the rain. The stage was purchased with the help of the Fannin County Fair Board and the Bonham ISD. Carriers will be made to help facilitate the movement of the stage from one location to another.

A electrical pedestal was damaged by a person leaving last month and it will be repaired this month. Replacement of the pedestal will occur.

Repairs to the grease trap will take place in April also due to a problem with the installation of the trap. Over time the trap had sunken down in the ground and stopped up the outlet from the kitchen sinks. What was originally thought to be a stoppage in the line turned out to be a blockage of the pipe where it exited in the grease trap.
