**Multipurpose Complex Update**

The multipurpose Complex has three events scheduled for February 2015. The Bonham Chamber of Commerce banquet on Feb. 7, a benefit concert for one of the local churches on Feb. 14, and a private party on February 28.

The fire monitoring system has been installed and we are scheduling the final inspection by the Bonham Fire Marshall for the first week of February.

The electrical bill for the main complex building in January was only \$585.94 which was an improvement over the January 2014 bill of \$648. This is this first month that we could compare the costs since we starting using propane for heating in Jan. 2014. The demand cost for Jan. 2015 for \$428 while in Jan. 2014 it was \$449.

The USDA grant request is to be discussed during the first week of February 2015 and we should get some feedback in the next few weeks.
