**Multipurpose Complex Update**  
**By Dale McQueen**

The multipurpose Complex has two events scheduled for March 2015. The Chi Lambda event on the 21st and Morning Star Rise and Shine 5K on the 28<sup>th</sup>. The Fannin County 4-H group will be having dog training sessions for 6-7 weeks (once a week) starting on March 16<sup>th</sup>.

The fire monitoring system has been installed but we are having problems getting a cell phone signal to meet the state requirements. The signal is acceptable only part of the time. The installation company is working on a permanent fix.

The electrical bill for the main complex building in January was only \$682. This was only \$100 over the Feb. 2014 bill but much less than the Feb. 2013 bill of \$2,225 dollars.

All the 400 Watt Metal Hydride bulbs in the main building were replaced this month with new bulbs. Many of the previous ones were getting old and turning yellow when on. We also replaced one additional fixture that no longer worked with a new 32 watt halogen bulb fixture. The cost to run the 32 watt fixtures is ½ the 400 MH fixtures. This month we are going to try and replace all the outside 1000 watt MH lights around the building with some of the 155 Watt LED's that are currently at the arena. The 1000 watt MH's will then go to the arena.

We are still waiting to hear from the USDA on the Grant request.

### **Bonham Area Chamber of Commerce Meeting Minutes**

**For February 3, 2015**

- 12) Invocation given by Angel Titsworth.
- 13) The meeting was called to order by Randy Bowen at 5:35pm.
- 14) Directors Report was given by Dale McQueen.
  - a. Chamber of Commerce Update:
    - i. Dale asked the board members about the new membership drive. Everyone is still working on their list.
    - ii. Fannin County Days funds will be an even wash with those funds.
    - iii. Fannin County Portal/website redo will be better, works on mobile devices better. Meeting graphic designer on Thursday with a 2 week goal.
    - iv. Financial Reports will be emailed to all board members prior to meetings for review and meeting prep.
  - b. Multi-purpose Complex Update:
    - i. Dale said Fire Suppression System is in place, it will be paid this week and done.
    - ii. Comparison of Propane bill – major difference for the better than two years ago.
    - iii. USDA grant request – more chairs, a floor scrubber, AC unit (waiting on a quote).
- 15) Approval of the minutes for January 6, 2015 meeting was made by John Ryan, seconded by David Adams, motion passed.
- 16) The board went back to approved the minutes from December's Board Meeting was made by Randy Pendergrass, seconded by Steve Murden, motion passed.
- 17) Financial Reports
  - a. Approval of finance reports for December were made by Randy Pendergrass, seconded by Tim Mayo, motion passed.
  - b. Balance Sheet, Profit & Loss – January 2015 – Bonham Chamber of Commerce

- i. Dale McQueen reported that the our income is increased right now with funds from Fannin County Days and Banquet rolling in. Only things to buy are silverware for \$425.
    - ii. Approval of Finance Items for Bonham Chamber of Commerce from January 6, 2015 meeting was made by John Ryan, seconded by Steve Murden, motion passed.
  - c. Balance Sheet, Profit & Loss - January 2015 – Multi-purpose Complex
    - i. Dale McQueen reported a decrease by \$2,400 and will go down more for the Fire Suppression System by about \$6,000 (which is more than anticipated).
    - ii. The complex has full bookings in the coming months and that will help pull the budget back up.
    - iii. County is hauling in rock on RV park (rock/diesel charge).
    - iv. A/C install did not have a bid and there was limitations in who could install – reason for such high price.
    - v. Approval of Finance Items for Multipurpose Complex from January 6, 2015 meeting was made by Tim Mayo, seconded by David Adams, motion passed.

#### 18) Reports

- a. Chamber Banquet – Becki Farris reported:
  - i. Committee is decorating Friday night
  - ii. Asked for board members to sign up to help out for the night of the banquet.
  - iii. Asked about name badges – Dale McQueen said he still needs to order them.
  - iv. It was discussed that Randy Bowen would be the speaker for the board with Steven Murden assisting.
  - v. Discussion about why we were not having an Ag Business Award this year. Board decided we need to add it to the future banquets, but to bypass it this year due to lack of time to get an award.
- b. Fannin County Days in Austin – Dale McQueen reported that everything is all set for this on Feb. 18<sup>th</sup>.

#### 19) Unfinished Business

- a. Randy Pendergrass said he would have a Chamber Golf Tournament date soon, but asked for an assistant. Kristy Agerlid volunteered to be the assistant for this event.

- b. Steve Murden discussed ways the Chamber can assist local businesses. One way might be to host web seminars for smaller businesses that could use the support and assistance. Possibly a Best Fest. This rolled into other ways the Chamber could offer similar benefits to its members. We decided to think on this and discuss more at Board Retreat coming up.

#### 20) New Business

- a. Discussion and action to appoint individuals to sign checks – Randy Pendergrass made a motion for Kristy Agerlid, Angel Titsworth, and Steve Murden to be check signers. (Dale will need a copy of the minutes to authorize these names with the bank.) John Ryan seconded. Motion passed.
- b. Membership drive committee for 2015 - Stephen Murden encouraged everyone to continue to work on their list of names.
- c. Remarks and discussion for Chamber Banquet – Randy Bowen opened the discussion about what the board wants to work towards this coming year for our community business members. He discussed his wording for the banquet and others commented on their thoughts.
  - i. Help you promote your business.
  - ii. Enhance our online assistance.
  - iii. Collaborate with other organizations to help promote.
  - iv. Continue to strengthen the foundation-recovery mode.
  - v. Push for Fannin County outside our walls.
  - vi. We need to do for all towns in the county, not just Bonham.
  - vii. Explore new business ideas, community calendar.
  - viii. Need more ethnic groups/diversity.
  - ix. Network nights
- d. Decided all are good things to table until Banquet Retreat. Banquet Retreat was set for Saturday, February 28<sup>th</sup> 9am – 1pm with the possibility of holding it at the Lake Bonham Pavilion.

#### 21) Other Business
