11) Discussion and action about Rates for Fannin County Multipurpose Complex for 2016 – Dale McQueen

- a. Rates presented by Dale were discussed and how they were set. Descriptions of how each rate is determined per event type were included in discussion.
  - i. \$2,300 – Gun Shows
  - ii. \$2,100 – Private parties using all the available chairs
  - iii. \$1,600 – Major fundraisers for 501 C organizations requiring more than 150 chairs
  - iv. \$1,500 – Weekend dog shows
  - v. \$1,000 – Minor fundraisers, Fannin County Church events using less than 150 chairs
  - vi. \$750 – All groups besides school and church groups requiring mostly an open building and the grounds
  - vii. \$500 – School fundraisers and church groups using mostly an open building and the grounds
  - viii. \$250 – Pavilions for 4H, FFA activities
  - ix. \$50 – Rental of arena for the day
  - x. \$0 – Day Clinics hosted by the agrilife office, Programs about agricultural presented to school age kids
